Northeast Hot Air RV'ers - Rules and Regulations

Please note: The parking area is not a "campground" - the club is only allowed to park on the airport grounds through the generosity of Warren County. The rules below have been created both based on the County's wishes and by club vote, and are designed to ensure the safety and enjoyment of all club members. Please obey the rules so that the club can continue to enjoy the Balloon Festival for years to come. **Any members, or their guests, found to be violating the club rules will be sent off site.**

If you have any questions, please email us or mention it at the membership meeting on the Saturday of the Festival.

RVs must be self-contained with integrated holding tanks - no porta-potties

- Any RV found to be discharging fluids will be required to clean up the site and will be asked to leave.
- We do not have dumpsters or a dumping station. What you bring in, you must take out, including trash and holding tank fluids. Sites must be completely clean at your departure.

RV Parking Area - The field is open for parking from 2:00 pm to 7:30 pm on Friday only.

- The club gathering lasts from Friday until Sunday. Members attending the event are expected to have their RVs stay on site until after the Sunday morning launch.
- If your RV must leave before the Sunday morning launch is over, please inform a row host/committee member as far in advance as possible prior to your departure so they may arrange for someone to escort to you out safely.
- A responsible adult must be present in the event that we need to unexpectedly move the RVs from the field (due
 to weather, emergency, or cancellation of the event).
- Any RV leaving the site will NOT be allowed back into the RV overnight area.

Towed Parking Area - Vehicles parked in the Towed Parking Area may come and go, field vehicles may not.

- Vehicles in the field may not move from Friday at dusk until after the Sunday morning launch.
- There is a separate, limited parking area for vehicles that wish to come and go during the weekend. If you have a tow vehicle you wish to drive during the weekend, you should detach it from your RV on Friday and park it in the Towed Parking area for the weekend.

Parking Permits Required - Permits must be affixed to your windshield at all times

- Vehicles must have a parking decal affixed to the windshield in order to be allowed through the gate.
- Vehicles found in the Towed Parking area without a permit will be towed at the owner's expense.
- Guests are welcome, but must park elsewhere. We do not have sufficient parking space for guests.

Quiet Hours - Quiet hours are from 10 PM to 5 AM and will be strictly enforced.

Generators/Engines- Please be courteous and limit generator use when possible.

- 12-FOOT EXHAUST STACKS ARE REQUIRED ON ALL GENERATORS AND ANY RUNNING ENGINES.
- No generators or engines may be run during Quiet Hours except for staff and medical use.

No Tent Camping - Easy-ups (without screens) are allowed. Members and overnight guests must sleep in the RV.

No Campfires or Open Flames - Propane grills are allowed for cooking, but no tiki lamps, charcoal, etc.

Pets - may be brought to the RV area but are not allowed at balloon launch sites. Leash and clean up rules are in effect.

No Golf Carts – Except for Staff use only. Motorized scooters are allowed for handicapped access.

Bikes, roller blades, scooters or skateboards are not allowed at any of the Balloon Festival activities including the RV area.

Other

- The road from the field to the airport is for Trolley and authorized use only. No pedestrian traffic.
- NO ALCOHOLIC BEVERAGES OR ILLEGAL DRUGS will be permitted on the airport grounds, including the RV parking area.
- No selling, concessions, or other business can be conducted in the RV area without prior permission from Warren County.
- FAA regulations prohibit drones at any airport.
